**DESCRIPTIVE SUMMARY**


This is an Amended Director's Report submitted by the Director of the Idaho Department of Water Resources (IDWR).

**DISCUSSION**

On February 26, 2019, IDWR filed a Director's Report for Bennie and Robert N Lowry's Water Right No. 95-10083 for irrigation and domestic purposes.

On August 28, 2020, Special Master Booth reviewed water right 95-10083 for issuance of partial decree. In his review, he found an error in the township within the place of use description. The place of use description should be T46N, R04W, S10 SWNE. The Amended Director's Report corrects the place of use description.

The Director submits for filing with the Court Amended Director's Reports for the aforementioned subcases (see attached recommendations).
