DESCRIPTIVE SUMMARY

This is an Amended Director's Report submitted by the Director of the Idaho Department of Water Resources (IDWR).


DISCUSSION

On February 26, 2019, IDWR filed a Director's Report for Randy D. Johnson's Water Right Nos. 95-15705 & 95-16128 for domestic purposes.

On September 21, 2020, Special Master Booth reviewed water right 95-15705 for issuance of partial decree. In his review, he found a discrepancy between the place of use and the point of diversion description and asked IDWR to review the discrepancy. In its review, IDWR found that the place of use description should be consistent with the POD description and described as T48N, R04W, S17, Lot 3 (SWNE).

IDWR also found that 95-16128 shares the same place of use as 95-15705 and the recommended place of use for 95-16128 should be corrected as well. The Amended Director's Reports correct the place of use on both water rights.

The Director submits for filing with the Court Amended Director's Reports for the aforementioned subcases (see attached recommendations).
