may be ultimately determined by the Court at a point in time no later than the entry
of a final unified decree. Idaho Code § 42-1412(6).

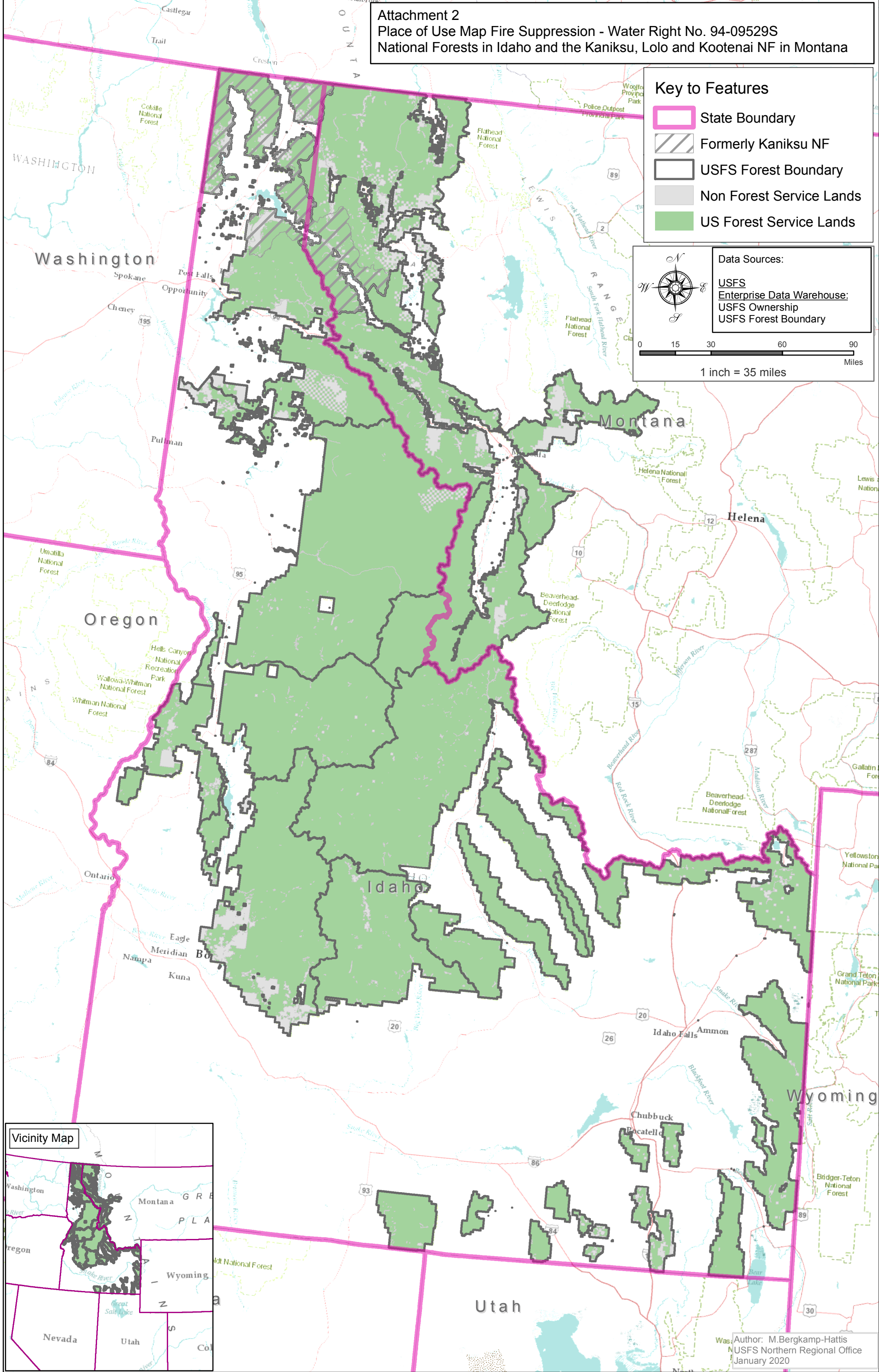
RULE 54(b) CERTIFICATE
