of a final unified decree. Idaho Code § 42-1412(6).

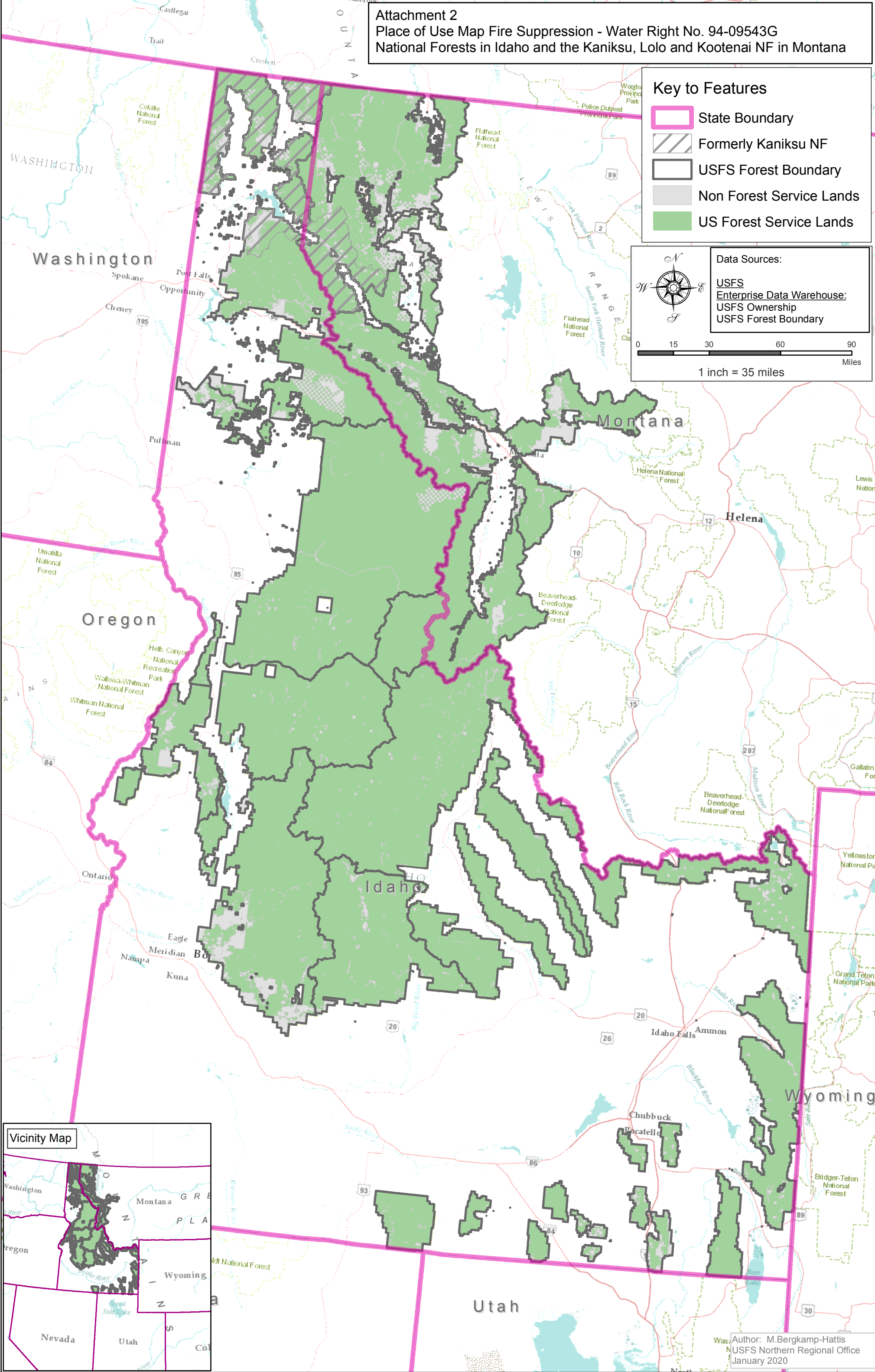
RULE 54(b) CERTIFICATE
